## Criteria

**In order to qualify for a CAMS Superlicence, please confirm that you are 17 years of age or above, and additionally comply with one of the following:**

1. Hold a minimum of an International C Circuit Racing Licence, have accumulated a minimum of 13 points under either the FIA or CAMS Superlicence points system during the five (5) years prior to the application for a CAMS Superlicence.  

OR
2. Have competed in a minimum of three (3) rounds of the Virgin Australia Supercars Championship within the last five (5) years.  

OR
3. Hold a minimum of a Gold FIA Driver categorisation.  

OR
4. Be one of the first six (6) of the final classification of the previous year's Super 2 Series. If one (1) or more driver/s currently holding a CAMS Superlicence are within the first six of the final classification, eligibility for a CAMS Superlicence would be extended up to the first eight (8) of the final classification of the Series.

**NOTE:** A driver who does not meet the criteria points 1, 2, 3 or 4 above may apply for a dispensation. Any such dispensation must be considered and jointly approved by CAMS and the Supercars Commission.
